

## Distribution Policy

This catalog describes software available from faculty research groups in the Department of Electrical Engineering and Computer Sciences at the University of California, Berkeley.

Generally, the Department's philosophy is to make the source code available "as is," as a public service, for research purposes. The open-software approach was well received with the SPICE program, and it has significantly contributed to the popularity of the UNIX operating system. Today, this open-software approach encompasses other programs such as the 1986 VLSI Tools, OctTools, EDIF, BSIM3, Ptolemy, SAMPLE Group Programs, and SPICE. It has resulted in mutually beneficial working relations with industry, government agencies, and other universities. This philosophy also promotes the open exchange of information within the academic community and allows students to take their programs with them upon completion of their degrees. Today, much of the computer-aided design work in the department is sponsored by companies with the implicit understanding that the results will be made available industry-wide.

The research software license agreement form, on the back of the order form, describes the conditions governing the distribution of our software programs. This form must be signed by an authorized representative of your organization to indicate that the licensee has read and will abide by the conditions of the agreement. These conditions arise from concerns expressed by the EECS faculty, Regents of the University of California, U.S. Government, and research sponsors.

**Please note:** The University is not liable for any infringement of copyright or other proprietary rights brought by third parties against the licensee of the software/documentation provided under the agreement. The University does not have the same controls over its faculty, students, and staff that a private company would have over its employees. The software/documentation is often the by-product of a research project and is provided to others for the cost of reproduction and distribution, as opposed to private companies, which would charge a much higher license fee, as they are operated on a **for profit** basis. The disclaimer of warranty means that the University cannot be held liable to the customer in the event the customer is sued for copyright or other proprietary right infringements. This is appropriate in a situation where, as here, an academic institution is providing the software basically for the benefit of other entities and only for the cost of distribution, reproduction, and materials.

To facilitate the use of the programs within your organization, unless otherwise stated in the program description herein, your organization may make an unlimited number of copies of code and documentation for internal use within your organization. However, the copies must bear the copyright notice appearing on the documentation and code as being for *internal* use only.

Most of our software may be freely redistributed either within your organization or to other organizations, both within the United States and abroad, subject to the following restrictions:

1. You must not charge for the University of California code itself. The research was supported by funds contributed by a wide variety of organizations and the faculty feel that the results should be made freely available. However, you may charge for additions, extensions, or support that you provide.
2. Any product based on University of California software must acknowledge in its documentation that the product is based on software developed by the [research group name], Department of Electrical Engineering and Computer Sciences, University of California, Berkeley.
3. Redistribution must conform to all U.S. Government restrictions, particularly those concerning export. These restrictions may even apply to redistribution within an internal organization. The University of California takes no responsibility for the export of any technology derived from its research.
4. For software with additional restrictions, the licensee agrees to all additional terms governing distribution of that software.
5. The licensee agrees to reproduce any copyright notice that appears on the software documentation provided under this agreement on any copy or modification of such made available to others by licensee.

Several programs carry special restrictions that are detailed in the catalog. For example, some software is based on licensed material and cannot be provided or redistributed without licenses from other organizations; other programs may not be redistributed without explicit permission from the authors. You must sign an additional letter of non-redistribution for each of these programs that you wish to obtain, and you may have to present particular licenses to obtain the software.

Some of the programs distributed by the Industrial Liaison Program's Software Distribution Office are not available outside of the United States. Please consult the program descriptions for foreign distribution availability. Those programs not available from this office for foreign distribution may often be obtained from software libraries such as DECUS -- ordering information for DECUS is available in the back of this catalog.

Should you wish to redistribute this software outside the United States (even within your own organization), it is your responsibility to ensure compliance with the distribution restrictions stated herein for each program, as well as with all government regulations restricting the export of technology.

We consider the documentation for research software to be equivalent to papers published in the open literature; thus the Industrial Liaison Program makes most documentation available outside the United States, provided that the recipient files a letter of assurance with the Industrial Liaison Program in advance.
